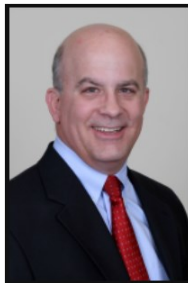

Based in Mercer's Richmond office, he provides clients with assistance in determining which individual insurance products might fit their needs. Bruce is the Leader for Mercer's Medicare Exchange, Transition Assist and for our Public Exchange access through GetInsured. Bruce also performs client work focused on health care strategy, establishment of employee contributions, actuarial evaluation of cost and cost drivers, underwriting and

technical support to national and Virginia-based clients in the areas of health care, life insurance and disability strategy, financial management and projections, network and vendor evaluations, valuation of liabilities including IBNR, ASC 715 and ASC 712, and integrated absence management modeling and strategy. Prior to assuming his current role, Bruce was Mercer's Health and Benefits chief actuary.

Prior to joining Mercer, Bruce has worked as chief actuary for both a major multi-line insurer, a leading life and disability insurer, a student health insurer and also worked for a leading health care carrier. He has extensive experience in designing benefit programs, pricing, underwriting, financial management, claims and liability valuation, and product design elements of disability and health insurance programs.

Since joining Mercer, Bruce has worked with client to assist them in understanding the financial performance and emerging trends associated with their health care benefit programs. This analysis has included financial modeling and budgeting, identification of emerging trends and their root causes, evaluation of care management programs, and the evaluation of liabilities associated with the benefit plans. He currently spends the majority of his time working with the Federal Express Corporation and Lockheed Martin Corporation among other national clients.

Sigma Chapter Attends the 43rd Annual Gamma Iota Sigma Management Conference

From October 2-4, 2014, officers and advisors of the Sigma Chapter were in Dallas, Texas to attend the 43rd Annual Gamma Iota Sigma Management Conference, co-hosted by the Beta Zeta Chapter at the University of North Texas. The conference offered a comprehensive agenda, including a career fair, educational and leadership sessions, and keynote addresses.

The Sigma Chapter received Chapter Awards for its achievements in Alumni Relations, Chapter Management, Community Service, Membership Development, and Public Relations. These five Chapter Awards earned the Sigma Chapter a Superior Chapter Award, which was given to only three other chapters at the conference.
