20th Annual Awards for Excellence Luncheon

Each spring, the Department of Risk, Insurance and Healthcare Management hosts our Annual Awards for Excellence Luncheon. This annual event is widely anticipated by the risk management, insurance and actuarial science community and is attended by a large number of individuals, students and alumni of our program. During the luncheon, we recognize top students in our program and also hear an address from a leader in the field. **This year, the luncheon will take place on Tuesday, April 22, 2008 from 11:30am to 2:00pm.**

In previous years, this event has been attended by more than 600 guests, including industry professionals, alumni, and students. The Luncheon provides a great opportunity to meet industry peers, Temple's outstanding Risk, Insurance, and Healthcare Management faculty and graduating students and to listen to outstanding individuals speak on current topics.

For this year's keynote speaker, we have secured the services of the **President and Chief Executive Officer of American International Group (AIG), Martin J. Sullivan.** Mr. Sullivan served as Vice Chairman and Co-Chief Operating Officer from May 2002 until March 2005, when he was elected to his current position. He also serves on the AIG Board of Directors.

Mr. Sullivan joined the company in the Finance Department of American International Underwriters (AIU), AIG's non-life insurance company in the United Kingdom, in 1971. In 1974, he joined the Property Department and held a succession of underwriting and management assignments in the UK and Ireland. In 1983, Mr. Sullivan was appointed Property Manager for the UK and later Regional Property Manager for the UK/Ireland Division.

In 1988, Mr. Sullivan was named Manager of AIU's London office and Regional Marketing Manager for UK/Ireland. He was later appointed Assistant Managing Director of AIG Europe (UK) Ltd. in 1989 and Chief Operating Officer in 1991. In 1993, he was named President of AIU's UK/Ireland Division and Managing Director of AIG Europe (UK) Ltd.

Mr. Sullivan was elected Senior Vice President, Foreign General Insurance in 1996 and Executive Vice President, Foreign General in 1998. In



1996, he was appointed Chief Operating Officer of AIU in New York and named President in 1997.

Mr. Sullivan is Chairman of the US-ASEAN Business Council, an Associate Member of the Chartered Insurance Institute, a Fellow of the Institute of Leadership & Management and a Member of the Chartered Management Institute. He also serves in the following capacities: a Director of the Geneva Association; a member of the Business Advisory Committees of the St. George's Society and The British Memorial Garden Trust; a member of the American Advisory Council of the London Symphony Orchestra; a member of the International Advisory Council of Guanghua School of Management at Peking University; a member of the Board of Trustees of the American Associates of the Royal Academy Trust; a member of the Board of Overseers – School of Risk Management, St. John's University; and a member of the Board of Directors of the Inner City Scholarship Fund. He was also formerly the President of British American Business Inc.

Mr. Sullivan was made a member of the Order of the British Empire in the 2007 Queen's Birthday Honors list.

He is married and has two daughters and a son.

Intern Testimonial: Kirill Palatnik

Kirill Palatnik is a senior graduating in May 2008 and majoring in Risk Management. In the summer of 2007, Kirill interned at Mercer in Norwalk, Connecticut. *Risky Business* sat down with Kirill to ask him about his experience there.



RB: How well did you handle the transition to Connecticut?

Living in Connecticut wasn't too difficult since I moved into a suburban location that was fairly similar to where I live now. Also, there were a number of other interns that lived in close proximity, which made up for the fact that was unable to visit home.

RB: What sort of tasks did you perform on a regular basis?

Many of my daily obligations included completing HMO [Health Maintenance Organization] and Medicare HMO renewals and formulating accrual rates. Since Mercer is a consulting firm which aids employers in the procurement of medical, dental, and vision insurance for their employees, the other interns, workers and I were divided into various teams for different clients. A senior-level consultant led each of the various groups and served as team leader.

RB: Did you feel that your RMI classes assisted you in your internship?

RMI 205 was particularly helpful over the course of the internship. I was the only intern that already understood the various concepts like HMOs, PPOs [Preferred Provider organization], ASOs [Administrative Services Only] and self-insurance. Quite a few of my co-workers were surprised that I

had exposure to these concepts in school and noted that I wouldn't be needing a crash course those topics, unlike the rest of the interns and new hires.

RB: Did you work on any special or long-term projects?

One project I worked on dealt with Medicare HMO renewals for a major Mercer client. I was responsible for contacting all HMO vendors and procuring proposals for the following year. Then, I organized the vendors' responses into an Access database for intra-company usage.

RB: Was there anything in particular you enjoyed about the experience?

One of the best things about the internship was the housing. Mercer provided a hotel suite directly across from the office. The accommodations were great and I also ended up enjoying a few team lunches, dinner cruises as well as a trip to an amusement park, all of which was sponsored by Mercer. In addition, I found the work environment at Mercer and my co-workers in general wonderful. I was pleased that I was able to earn a great degree of trust from his co-workers by the end of the summer. Overall, I immensely enjoyed the internship at Mercer and would recommend the company to anyone.
